TRIPS: I give permission for my child to go on camp trips and swimming trips with Bright Star Camp.

TRANSPORTATION: If weather conditions make driving hazardous, the camp will not be obliged to provide transportation. If taking Bright Star transportation, the parent assumes full responsibility for the child to and from the transportation vehicle. For children under four years of age, the parent must provide an appropriate car seat and secure the car seat onto the bus. The parent must put the child on the bus and secure the child in the car seat and when exiting, remove the child from the bus. There are no refunds for cancelled transportation due to weather conditions or mechanical failures.

TUITION: A \$300 deposit will be paid in order to guarantee a place for the camper when camp begins. The deposit fee is non-refundable after March 1st. All camp tuitions are due by May 15th. Camp tuitions and insurance fees are non-refundable. There are no refunds or make-up days due to absence, illness, vacations or any other reasons. Camp will close earlier than 6:00 p.m. if camp registration is not sufficient.

WITHIN TWO WEEKS: if in the opinion of the camp director, they observe, that your child is not happy during camp after a two week period, the unused portion of the fee will be refunded. The insurance fee is not refundable. In addition a \$100 clerical fee will be charged.

Other Charges: \$30 fee will be charged for returned checks
\$100.00 fee per hour will be charged for any child picked up after 6:00 pm
Additional hours other than scheduled will be \$12 per hour

There will be a \$100 fee for any schedule changes after May 15th (unless adding days).

Bright Star Camp reserves the right to terminate this contract at any time for any reason.
